The CMP is, per federal definition, a systematic process that provides safe and effective integrated management and operation of the multimodal transportation system. A CMP is required in metropolitan areas with population exceeding 200,000, known as Transportation Management Areas (TMAs). As a TMA, the MPO is updating the CMP to serve as the organizing framework for all transportation planning activities in our metro area. MPO staff is seeking recommendation by the TAC for Transportation Policy Committee approval of the updated Congestion Management Process.
