#### A. Transportation Alternatives Set-aside Program

The Transportation Alternatives (TA) Set-aside program—formerly the Transportation Alternatives Program (TAP)—was authorized under Section 1109 of Fixing America's Surface Transportation Act (FAST Act), the current federal transportation bill. In accordance with best practices from other MPOs in Transportation Management Areas (TMAs) in Texas and guidance from Federal Highways Administration (FHWA), MPO staff is seeking approval from TPC to uphold the previously approved implementation process while expanding allowable project costs to include design costs not to exceed 10% of total construction cost.
