Federal regulations require that the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) conduct a joint planning certification review at least once every four years for large metropolitan areas.

For the Corpus Christi Area, the metropolitan transportation planning process is led by the Transportation Policy Board of the Corpus Christi Metropolitan Planning Organization (CCMPO) in cooperation with the region's transportation partners (e.g., CCRTA, Texas Department of Transportation, etc.). The Federal Certification Review will be conducted February 11-13, 2026, at the Corpus Christi Metropolitan Planning Organization offices, located at 602 N. Staples Street, Suite 300 Corpus Christi, TX 78401, Ph:(361)884-0687. Additional information for this meeting will be available on the MPO website.

As part of this process the Federal Highway Administration and the Federal Transit Administration are seeking public input concerning the metropolitan transportation planning process within the Corpus Christi metropolitan planning area. Representatives from the Federal Highway Administration and the Federal Transit Administration will be available to receive public comment on the metropolitan transportation planning process at a **Public Listening Session February 12, 2026, from 4:30 pm to 7:00 pm at Staples Street Center, 602 N. Staples Street, Room 210, Corpus Christi, TX, 78401**. - 3) Are there specific areas that you feel CCMPO does well or could improve? Please explain your answer.
